Important Terms & Definitions

- **Customer Charge:** Customer Charge covers our cost to keep an electric account open, including metering, administrative and billing services, and is not dependent on the amount of electricity used.
- **Distribution / Access Charge:** Distribution / Access is the local delivery of electricity to retail customers. This portion of the rate covers the cost to build and maintain the local electric system, including substations, transformers, poles, wires, labor, administration as well as other costs associated with running the utility.
- **Transmission Charge:** Transmission Charge covers the utility's costs to move bulk electricity from power plants, over the transmission lines owned by utilities, to Chicopee's local substations.
- **Generation Charge:** Generation charge pays for charges related to the generation and power related costs needed to meet customer's energy demand.
- **Purchase Power Adjustment:** This is the difference between the utilities average power cost and the power base cost. It is calculated as a charge or credit over time in order to levelize fluctuations in actual power costs. This is applied to all customer class kWh's including off-peak kWh's.
- **Hydro Credit:** Hydro Credit savings are passed to our residential customers as a benefit from the Niagara Hydro Project. This credit is applied to all residential class kWh's including off-peak kWh's.
- **Primary Service:** Primary Service designates customers owning high voltage equipment and taking energy with a demand of 100 KW or more.
